AIRPORT ACTIVITY REPORT:

(Carl R. Beardsley, Executive Director)

DISCUSSION:

Mr. Beardsley explained that for the month of May, and for the tenth consecutive month, passenger boardings have increased. Our seat availability, as a whole, is down 4.8% as a result of seasonal schedule changes by American and United Airlines. Allegiant and Delta Air Lines increased the number of seats they offered, providing additional flights and larger aircraft. Our airline load factor is at a very strong 85%, which is 5 percentage points higher than what we experienced in May of 2015. On a very positive note, these numbers were across the board, with all airlines showing between 81% and 88% load factor. General Aviation flights were down 21% for the month of May, however, their year to date numbers have increased by 17% in comparison to the numbers from 2015.

Rehabilitate and Extend Hangar Road

Design and Construction Monitoring Services - L.R. Kimball. Contractor - Scartelli Construction.

Project work is complete and there is NO CHANGE IN STATUS as we continue to work to resolve project closeout issues.

Final Project is estimated at \$3.21 M

Project payments to date represent approximately 93% of total.

This project is broken out into three separate construction projects; Environmental Remediation, Building Demolition and Apron Construction.

We have submitted plans to PennDOT Bureau of Aviation and are working on addressing their comments. We are coordinating with the Bureau on details regarding timing of the bidding and grant funding requests with the DOT.

Current Project Costs are approximately \$709,000 Project payments to date represent approximately 88% of total. Funding - State Capital Fund Grant, Airport Generated PFC Funds.

ACP 14-03

Parking Garage Maintenance

Design Services - Desman Associates

No major change in status to report. We are working to complete our plan review with the intent to submit plans to the Bureau of Aviation, in anticipation of potential Capital Grant funding for the project from the State.

Current Project Costs are approximately \$72,088 Project payments to date represent approximately 69.8% of total. Funding - Airport Funds.

ACP 15-02

Master Plan Update and Airport Layout Plan (ALP) Update

Consultant - McFarland-Johnson

We continue assisting the Consultant with information gathering and we are reviewing potential projects identified in our stakeholder meetings. We anticipate work on the pavement survey and analysis will begin next week.

Current Project Costs are approximately \$902,000.

Project payments to date represent approximately 27.5% of total.

Funding - Federal AIP, State Aviation Grant, Airport Generated PFC Funds.

ACP 11-01 Extend Taxiway B (Runway 22 Approach End)

Design and Construction Monitoring Services - L.R. Kimball.
Construction of this project is to be completed over four construction projects. The first two, Site Preparation and NAVAIDs, have been designed and let for construction.
Site Preparation Contractor - Leeward Construction
NAVAIDs Contractor - Joyce Electric

Initial meetings on project closeout on the Site Preparation and NAVAIDs project were held last week to review final quantities and address project closeout costs. We anticipate closeout of the contracts with the Closeout Change Orders at the July or August meeting. Work on project and grant paperwork including as-builts is underway.

Bid packages for the remaining two phases: Taxiway Paving and Taxiway Lighting & Signage, were advertised and made available to bidders on May 31st. A pre-bid conference was conducted last Wednesday (June 8th) and bids will be received until June 28th, when they will be opened.

We have begun work on the application for FAA Funding and will incorporate these bid results along with other project costs into the Grant Application.

Current Project Costs are approximately \$12.1 M Project payments to date represent approximately 94.6% of total.

The remaining contracts for the project will be for Taxiway Paving and Taxiway Lighting & Signage. Estimated costs for construction and inspection approximately \$3,500,000.

Funding - Federal AIP, State Aviation Grant, Airport Generated PFC Funds.

ACP 15-03 Relocate TSA Checkpoint

Preliminary Study & Estimate - McFarland-Johnson Checkpoint Relocation - Fennick McCredie Architecture

We now have the Scope and Fee Proposal from the consultant and we are working on our review. We anticipate completing the contract for the project in the coming week. We project that the design effort will be completed before the end of the year.

CAPITAL PROJECTS - Cont'd...

Current Project Costs are approximately \$12,000. Project payments to date represent approximately 100% of total. Funding - Airport Capital Funds

ACP 16-01 Taxiways B & D (West) Rehabilitation

This project is the Rehabilitation of the existing portions of the main parallel taxiway to Runway 4-22 and to the portion of Taxiway D West of Runway 4-22.

We have advertised and yesterday received responses to our Request for Qualifications for the design of these taxiway rehabilitations.

A total of twelve packets were emailed to consultants and four responses were received. RDM International, Greenman Pedersen, LR Kimball, and McFarland Johnson were the respondents. Interviews will be scheduled for next week.

Design of the project will proceed through the end of this year and into the beginning of next and we anticipate bidding the first phase of what will likely be a two-phase construction in the 2017 construction season.

DISCUSSION:

Metz Culinary Management representatives Rick Sell and Jeff Metz briefed the Airport Board on the transition process currently in progress at the airport food concession. The new General Manager has been hired and has been on-site integrating with the current team. They have had 3 employee meetings, retaining most of the current employees and looking to hire 3-5 additional employees. The concession will be rebranded as "Lucky's Craft Food & Drink". Menu has been finalized and new uniforms ordered. The approval process to work with a local national franchise is complete and they are working on completion of an agreement, at which time an announcement will be made. Drawing and bidding for the kiosk bar, which will add seating to the existing area, is underway. The retail line and merchandise is being upgraded as well. Metz Culinary Management will officially take over the restaurant concession July 1, 2016.

DISCUSSION:

Mr. Beardsley briefed the Airport Board on the Quick Turn Around (QTA) Facility. This facility would be used by all the car rental companies which currently service AVP. Benefits of the QTA Facility would include new revenue from the land lease, improvement to the aesthetics of the airport, and better customer service. Site location options were given for optimal service. A feasibility study is the next step going forward with this project.
